PROMOTION DESCRIPTION:

HOW TO ENTER / EXECUTION:

- 1. Listeners of WIZF-FM and WOSL-FM ("Station or "Stations") who are legal residents of the United States residing within the Cincinnati, Ohio metropolitan area and are 18 years of age or older will be able to take part in this Sweepstakes. - 2.
