Spring Social Media Influencer OFFICIAL SWEEPSTAKES RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE A PARTICIPANT'S CHANCES OF WINNING.

SWEEPSTAKES DESCRIPTION: WIZF-FM and WOSL-FM's "Spring Social Media Influencer" Register-To-Win Sweepstakes ("Sweepstakes") will begin at 6:00AM Eastern Time ("ET") on Saturday, April 1, 2023, and end at 11:59PM ET on Sunday, April 30, 2023. Registration for this Sweepstakes will be held online and in-person at the Ohio Media School, located at 4411 Montgomery Rd Ste 200, Norwood, OH 45212. One (1) winner will be selected per station, for a total of two (2) winners. Each winner will be awarded a "Social Media Influencer Prize Pack," consisting of one (1) HPUSN 18-inch Ringlight Kit, valued at Seventy Dollars (ARV \$70) and one (1) Samsung 4 Chrome OS 11.6-inch HD Chromebook, valued at One Hundred Forty-nine Dollars (ARV \$149) (Total ARV \$219) ("Prize").

HOW TO ENTER / EXECUTION:

Listeners of WIZF-FM and WOSL-FM ("Station" or "Stations") who are legal residents of the United States residing within the Cincinnati, Ohio metropolitan area and are 18 years of age or older will be able to take part in this Sweepstakes. There are two (2) methods of Sweepstakes entry: (a) in-person and (b) online. To participate in the Sweepstakes, listeners must do the following:

1. <u>In-person Registration:</u>

- e. All in-person entries will be scanned by Station staff and randomly entered into the electronic WIZ-FM and WOSL-FM drawing pools on Sunday, April 30, 2023.

2. Online Registration:

- a. During the Sweepstakes Period, eligible participants must register online through the Station's websites at wiznation.com (for WIZ-FM) or rnbcincy.com (for WOSL-FM). Participants may only register through one Station's website throughout the Sweepstakes Period.
- b. Upon entering the Station's website, participants are to follow the on-screen instructions on the online entry form, including entering their name, date of birth, address, phone number, email address, and any optional or additional contact information, as requested, for a chance to win.

- c. All Internet entries must be received by 11:59PM local time on Sunday, April 30, 2023, or they will be void.
- d. In the event of a dispute regarding the identity of a participant's online entry, the entry will be deemed to have been made by the authorized holder of the e-mail account at the time the entry was made.
- e. Online Winners will be selected by random drawing from among all eligible entries received electronically.
- 3. After completing either the in-person or online registration process, participants will be eligible for a chance to win.
- 4. One entry per person during the Sweepstakes Period regardless of entry method.
- 5. At the conclusion of the Sweepstakes period, one (1) winner per Station, for a total of two (2) overall winners, will be selected by random drawing.
- 6. Station shall announce Winners live on-air on Monday, May 1, 2023, during Station's 10:00AM 3:00PM broadcast.
- 7. Winners will be notified by phone and/or email.
- 8. Winners must provide valid identification (e.g., via valid state-issued driver's license, passport or other government-issued I.D. containing the person's name, date of birth, and photograph) and a completed W9 form to claim the prize. Identification documents must match information previously provided to the Station.
- 9. Prizes will be awarded only upon winner verification and final approval by the Station.
- 10. Entrants agree to be bound by the terms of these Official Rules and by the decisions of Station management which will be final and binding in all matters pertaining to this Sweepstakes.

ELIGIBILITY RESTRICTIONS:
